

RESOLUTION NO. 2025-14

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIDWAY CITY SANITARY DISTRICT OF ORANGE COUNTY ELECTING TO BECOME SUBJECT TO THE UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT

THE BOARD OF DIRECTORS OF THE MIDWAY CITY SANITARY DISTRICT FINDS AND DETERMINES AS FOLLOWS:

A. Prior to the passage of Assembly Bill No. 1666, Chapter 1054, Statutes of 1983, which added Chapter 2, commencing with Section 22000, to Part 3 of Division 2 of the California Public Contract Code, existing law did not provide a uniform cost accounting standard for construction work performed or contracted by local public agencies.

B. California Public Contract Code section 22000 *et seq.*, the Uniform Public Construction Cost Accounting Act (the "Act"), sets forth such a uniform cost accounting standard.

C. The Commission established under the Act has developed uniform public construction cost accounting procedures for implementation by local public agencies in the performance of or in the contracting for construction of public projects.

D. The District desires to elect to become subject to the Act for the purpose of awarding public project contracts set forth in the Public Contract Code section 22000 *et seq.*

E. The District finds that utilizing the procedures outlined in the Act will save administrative time and expense and will be in the best interest of the District.


F. The California Public Contract Code section 22030 provides that any public agency that wishes to utilize the alternative procedures for bidding and contracting for public projects must elect, by resolution, to become subject to the uniform construction cost accounting procedures set forth in the Public Contact Code and must notify the State Controller of its election.

NOW, THEREFORE, the Board of Directors of the Midway City Sanitary District resolves as follows:

Section 1: Pursuant to the authority set forth in the Uniform Public Construction Cost Accounting Act, California Public Contract Code section 22000, *et seq.*, the Midway City Sanitary District hereby elects to become subject to the uniform construction cost accounting procedures set forth in Act and to the policies and procedures manual and cost accounting review procedures established thereunder, as each may be amended from time to time.

Section 2: The General Manager of the Midway City Sanitary District shall notify the State Controller of the District's election pursuant to Section 1 above.
