GM K. Robbins reported that he is expecting Cal OSHA to come out with their decision regarding a vaccine mandate requirement on Thursday, November 18, 2021. The District has concerns because this could potentially drive a few drivers and mechanics to retire early, although they will most likely allow weekly testing, which could help. He stated that CR&R drivers and their services could be affected and as well as nationwide because there is already a shortage of drivers.

GM K. Robbins reported that one Midway City Sanitary District driver would be retiring on December 31, 2021 so the District would be recruiting and replacing him.

President A. Nguyen reported that OC San had an audit, with everything coming out normal. He reported that they have enough funds to cover an emergency or disaster and their trust fund accounts with PARS (Public Agency Retirement Services) total \$15 million.

BOARD CONCERNS/COMMENTS

Director T. Diep stated that the District Franchise Committee should meet with the District's new CR&R representative sometime this month.

Director C. Nguyen stated that the District should schedule to do radio shows this month with or without the new CR&R representative because it is part of their agreement with the District.

GM/STAFF CONCERNS/COMMENT

GM K. Robbins wished everyone a Happy Thanksgiving and reminded them that the District office would be closed on Thursday and Friday, November 25 and 26. The District solid waste drivers would be working Friday and Saturday to complete solid waste service to those District routes.

Finance/HR Director R. Housley stated that, with regard to the possible vaccine mandate, the District is a member of WEROC and was able to obtain 250 COVID-19 self-test kits at no cost. If Cal OSHA does decide to mandate the vaccine, these will come in handy as the cost for weekly testing for unvaccinated employees will fall on them, not the District. He also stated that since the change was made to District employee's comp time on the new MOU, attendance had improved overall and he wished everyone a Happy Thanksgiving.

GENERAL COUNSEL CONCERNS/COMMENTS

General Counsel, J. Eggart stated that during the November 2, 2021 meeting, the Board lost quorum while the closed session was taking place, and stated for the record that no reportable action was taken at that closed session prior to losing quorum. He also stated that, at the Tuesday, December 7, 2021 meeting, the Board would probably be considering updates to the District's solid waste regulations to address all of the changes required by CalRecycle with SB1383 (organics), as well as an agreement between the District and the City of Westminster allocating responsibility with respect to certain SB 1383 compliance activities.
