

ORDINANCE NO. 19

AN ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT, OF ORANGE COUNTY, CALIFORNIA, AMENDING SECTION 9 OF ORDINANCE NO. 15 OF SAID DISTRICT; REPEALING ALL MOTIONS, RESOLUTIONS AND ORDINANCES INCONSISTENT HEREWITH TO THE EXTENT OF SUCH INCONSISTENCY.

THE BOARD OF DIRECTORS OF THE MIDWAY CITY SANITARY DISTRICT, of Orange County, California, does ORDAIN as follows:

Section 1: That Section 9 of Ordinance No. 15 of this District be and the same hereby is amended to read as follows:

"Section 9: Use of Bins. Whenever, in the opinion of the Refuse Supervisor, it is convenient and necessary to the proper administration of this ordinance, he may require any person requesting service to utilize the refuse bin service provided by the District. Upon such requirement, the person requesting such service shall deposit with the District the sum of \$105.00 as a security deposit on each bin to be provided and, in addition thereto, a sum equal to one year's bin service charges as set forth below.

6/2/75 "During the period of such usage, a bin service fee shall be charged to such person as follows:

- "(a) For general commercial establishments and church uses - the sum of \$2.00 per month.
- (b) For multiple residential and mobile home park uses - the sum of \$2.50 per month.
- (c) For restaurants, drive-ins, cafes and other food service establishments and for public and private schools - the sum of \$3.00 per month.
- (d) For any use not included within the above described categories - a fee as shall be determined by the Board of Directors, which shall be not less than \$2.00 nor more than \$3.00 per month.

"Said bin ^{usage}~~storage~~ fees shall be payable annually in advance. In the event of termination prior to expiration of any such annual period, an appropriate proportionate credit or refund shall be made.

"Upon termination of refuse collection service and return of the bin in satisfactory condition, a refund of deposit shall be made to the applicant in the sum of \$90.00 less the amount of outstanding bin storage fees owed by said applicant.

"All such bins shall be located on private property at a place satisfactory to the Refuse Supervisor."

Section 2: Repeal. That all ordinances, resolutions and motions, and parts thereof, inconsistent herewith be and the same hereby are repealed to the extent of such inconsistency and no further.

Section 3: The Secretary of the Governing Board of this District shall certify to the passage of this ordinance and shall cause the same to be published once in a newspaper of general circulation in the Midway City Sanitary District, of Orange County, California, and this ordinance shall be in full force and effect.
