### **Report of General Manager**

GM K. Robbins reported that he spoke with several other waste haulers while at the Garbageman's Invitational Golf Tournament, that they all had major staff issues during the height of the COVID-19 pandemic and that the District did really well in comparison.

GM K. Robbins reported that the District submitted an application to the COVID-19 Fiscal Relief for Special Districts Fund through California Special Districts Association (CSDA) for the \$254,000 in unincumbered losses due to the pandemic, but that people who actually lost revenue would be the first to receive any financial reimbursement.

GM K. Robbins stated that the District office would be closed half-day on Thursday, December 23 and 30 and all day on Friday, December 24 and 31, 2021 for the Christmas and New Year's holidays. He stated that the solid waste drivers would be working on those days however, because they do not want to work on Sundays.

GM K. Robbins stated that he set it up so that the Board could call and make arrangements for their new portraits at their convenience. He also stated that he would need their new signatures for the District's annual calendar.

GM K. Robbins stated that the Board was provided with information regarding outreach done by CR&R and a schedule through the rest of the year.

D. Consideration of Conducting Teleconference Meetings Pursuant to Assembly Bill 361

General Counsel James Eggart stated that the Governors Executive Order authorizing exceptions to the Brown Act Teleconferencing Provisions expired on September 30, 2021. The legislature passed and the Governor signed a new bill, AB361, that continues to allow public agencies to meet virtually or remotely with relaxed rules but with some notable differences. AB361 sunsets at the end of 2024, only applies during a governor declared state of emergency (which we are still in due to COVID-19), and the Board would have to make one of two findings – 1) State and local officials have imposed or are recommending measures to impose social distancing, or 2) the Board would have to find that as a result of the emergency, meeting in person would present risks to attendees. The findings would have to be renewed every thirty days and the District would have to provide internet for the teleconference meeting.

Board discussion ensued.

General Counsel James Eggart stated that the Board could still hold teleconference meetings under the general rules, which would mean posting an agenda at the other location and giving the public access to that location.

A motion was made by Director T. Diep, seconded by President Pro-Tem C. Nguyen, to declare a need under AB361 to conduct Board meetings via teleconference for those who do not want to meet in person and direct staff to bring back a resolution to the next meeting. The motion was approved by the following 4-0 vote:

#### **BOARD CONCERNS/COMMENTS**

General Counsel, James Eggart stated that California Governor Newsom signed some bills regarding solid waste and recycling into legislation this week including a one-year grace period for penalties or fines for Cities or Districts regarding SB1383, a bill preventing restaurants from providing single-use serviceware items like plastic forks, condiments, etc. and a bill modifying the rules governing representations of recyclability and when the chasing arrows symbol may be used to better reflect if products and packaging are indeed

recyclable. There are others and he stated he would make a list and provide it to the General Manager.
