GENERAL REGULATION ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT, OF ORANGE COUNTY, CALIFORNIA, AMENDING SECTION 1, AS AMENDED, OF GENERAL REGULATION ORDINANCE NO. 1 OF SAID DISTRICT

THE GOVERNING BOARD OF THE MIDWAY CITY SANITARY DISTRICT, of Orange County, California, does ordain as follows:

Section 1: That Section 1, as amended, of General Regulation
Ordinance No. 1 of the Midway City Sanitary District be, and the same hereby
is amended so as to read as follows:

"Section 1: The Governing Board of the Midway City Sanitary District shall hold two regular official meetings of said Board at 14451 Cedarwood Street, Westminster, Orange County, California, during each calendar month on the first Thursday and on the third Thursday of each month at the hour of 7:00 p.m."

Section 2: That all motions, resolutions, and ordinances, and parts thereof, in conflict herewith be and the same hereby are repealed to the extent of such conflict and no further.

Section 3: The Secretary of the Governing Board of this District shall certify to the passage of this ordinance and shall cause the same to be published once in the Westminster Herald, a newspaper of general circulation, printed, published, and circulated in the Midway City Sanitary District, of Orange County, California, and this ordinance shall be in full force and effect at the expiration of one week from and after the date of its final passage.
